

Economists see the budget deficit this year reaching twice the target rate of 3.0 percent of GDP, or 15.2 billion shekels.

Jonathan Katz, head of the Israel Forecasts consultancy, predicts a half-point cut and further smaller cuts to reach a 6.0 percent key rate by the end of the year as long as there is no "dramatic fall" by the shekel.
